**RESOLUTION NO. 3-2014**  
**RESOLUTION OF THE BOARD OF DIRECTORS OF THE**  
**TEMPLETON COMMUNITY SERVICES DISTRICT**  
**REVISING FEES AND CHARGES FOR WATER AND WASTEWATER**  
**NON-PAYMENT AND VIOLATIONS OF THE DISTRICT'S WATER**  
**CONSERVATION ORDINANCE**

**WHEREAS**, the Board of Directors of the Templeton Community Services District ("District") proposes to revise the fees and charges for water and wastewater non-payment and violations of the District's water conservation ordinance; and

**WHEREAS**, the Board of Directors held a public hearing on March 18, 2014, to consider comments to the proposed revisions to the fees and charges for water and wastewater non-payment and violations of the District's water conservation ordinance.


**NOW, THEREFORE, BE IT RESOLVED** by the Board of Directors of the Templeton Community Services District as follows:

1. That the Templeton Community Services District's fees and charges for water and wastewater non-payment and violations of the District's water conservation ordinance, attached hereto as Attachment "A" and incorporated herein by this reference, are hereby adopted and shall become effective upon adoption of this Resolution.
2. To the extent that the terms and provisions of this Resolution may be inconsistent or in conflict with the terms or conditions of any prior resolution, rule or regulation concerning fees and charges for water and wastewater non-payment and violations of the District's water conservation ordinance for the Templeton Community Services District water and wastewater systems, the terms of this Resolution shall prevail and any such inconsistent and conflicting provisions of prior ordinances, resolutions, rules or regulations are hereby repealed.
3. If any provision of this Resolution or application thereof to any person or circumstance is held invalid, no other provision of this Resolution shall be affected thereby.

4. The modification and revision of the above fees and charges for the Templeton Community Services District, are, among other things, for the purpose of continuing to provide funds to meet the costs of operating and maintaining the water and wastewater systems within the Templeton Community Services District. The Board therefore finds that the adoption of this Resolution is exempt from application of the California Environmental Quality Act pursuant to Section 21080(b)(8) of the California Public Resources Code and authorizes the President to execute the Report on Review for CEQA Exemptions and the General Manager to execute and file a Notice of Exemption.
  
5. The fees and charges set forth above are not discriminatory or excessive, comply with Government Code Sections 54340, et seq. and otherwise comply with all applicable laws and regulations.

The foregoing Resolution was duly passed and adopted by the Board of Directors of the Templeton Community Services District at a regular meeting held on this 18<sup>th</sup> day of March, 2014, by the following vote:
